When you place an order with us and we accept your order, these terms and conditions become binding.

Please read them carefully and ask us any questions in advance of placing an order.

Please note that we only deal with consumers (individuals buying products from us for personal use, and not for use in connection with a trade, business, craft or profession). How we contact you

We will contact you by telephone or by email or post using the contact details provided on your order form.

Our contract with you

- Prior to accepting your order, you will be required to read and agree to our terms and conditions. If you fail to do so, then these terms will nevertheless be incorporated into our contract.
- Our acceptance of your order will take place when you have paid in full the first invoiced amount at which point a contract will come into existence between you and us which will incorporate these terms and conditions.
- We will assign you with an order number and let you know what this is. It would be helpful if you would quote this number whenever you contact us about your order.
- We do not accept orders from outside of the UK, and we only deliver to the UK mainland.

Our Products

All invitation suites produced by Exquisite Organza are bespoke. The images of our products on our website are of stationery produced by Exquisite Organza, but there may be slight variations between those images and others produced for you. We also cannot guarantee that your device will show the colours accurately and accordingly would encourage you to order a generic sample from us and locally source the Berisfords satin ribbon to make sure it is the colour you require. I will purchase the ribbon. If you require organza ribbon the colours available are always gold or silver grey.

Ordering and Production Process

We're pleased that you are considering ordering your wedding stationery and/or wedding poetry from Exquisite Organza, and want to make the process as simple as possible for you. We have set out below the stages. Please note that we do not commence work on any stage prior to receiving payment in full, and it is your responsibility to ensure all information that you provide (including measurements and grammatical requirements) are accurate.

Prices

- The price payable for the products we are delivering for you will be shown on the order form. The prices can also be downloaded from our website.
- No VAT.
- You must pay for all products we sell in advance of us commencing work on them. This reflects that all of our products are bespoke to you.
- Payment is accepted by **Bank transfer only** – details on the invoice.
- Exquisite Organza reserves the right to alter its prices. However, all orders placed with first payment received, will have prices honoured.
- Signed for postage will be added to orders.

Refunds and your rights as a consumer

- As you are a consumer, we are under a legal duty to supply products that are in conformity with our contract.
- We do not offer refunds or exchanges on products supplied by us unless they are faulty or unless you are otherwise entitled to a refund or exchange under your statutory rights as a consumer.
- All of our products are bespoke, made to your specifications and are personalised. Accordingly, once you have made payment for a product (or a stage of a product) you will not have any right to cancel our contract under the Consumer Contract Regulations or otherwise.

Limitation of Liability

- We will not be liable to you for any delay in providing the products to you, if and to the extent that the delay is caused by you not making payment for the products, and/or not promptly providing us with the information required to complete your order.
- Our maximum liability to you will be limited to the money paid by you to us for the relevant order.
- We will not have any liability to you if and to the extent that you use any products provided by us for any purpose other than as a consumer.
- No part of these terms and conditions is to be interpreted as limiting in any way our liability to you where it would be unlawful to do so.

Other Terms

- You need our consent to transfer your rights or your obligations under our contract to anyone else.
- Our contract is between you and us. No third party may rely on or enforce it.
- If we delay in taking any steps to enforce our contract, that delay does not constitute a waiver of our right to enforce it in the future.
- The laws of England and Wales apply to our contract, and the courts of England and Wales have exclusive jurisdiction over any disputes (including non-contractual disputes).
